RESOLUTION NO. 2019-12-1**

**A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES AND ADOPTING A BUDGET FOR THE NORTH SHORE WATER DISTRICT, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 2020, AND ENDING ON THE LAST DAY OF DECEMBER, 2020.**

**WHEREAS**, the Board of Directors of the North Shore Water District has appointed Katie Nicholls to prepare and submit a proposed budget to said governing body at the proper time; and

**WHEREAS**, Katie Nicholls has submitted a proposed budget to this governing body on October 9, 2019, for its consideration; and

**WHEREAS**, upon due and proper notice, published or posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on November 20, 2019 and December 11, 2019 and interested taxpayers were given the opportunity to file or register any objections to said budget; and

**WHEREAS**, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE NORTH SHORE WATER DISTRICT, COLORADO:**

Section 4. That the budget hereby approved and adopted shall be signed by the President and attested to by the Secretary/Treasurer of the Board, and made a part of the public records of the District.


